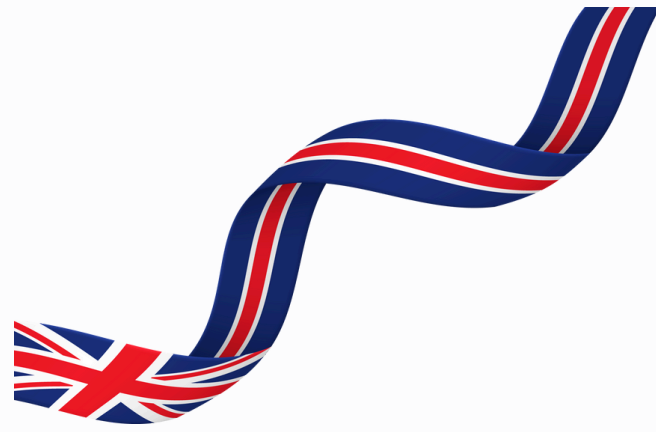

6 – Forbidden & Restricted Products

Certain products are prohibited or restricted under UK import regulations and may not be accepted under DDP terms. These typically include, but are not limited to, hazardous materials, counterfeit goods, weapons, ammunition, explosives, controlled chemicals, drugs, medical products without authorization, tobacco, alcohol, food items requiring special permits, and goods that do not comply with UK safety or conformity standards. Import acceptance remains subject to customs approval and regulatory compliance.

7 – Important Notes / Disclaimer

All transit times, cost indications, and service details are estimates and subject to final confirmation at booking, carrier acceptance, and customs requirements. Actual timelines and costs may vary due to inspections, port or airport congestion, regulatory changes, or external operational factors.

8 – Required Information for Quotation

To provide an accurate DDP quotation to the United Kingdom, clients are required to submit complete shipment details, including product description, HS code (if available), quantity, total weight, total volume (CBM), packaging type, origin of goods, and final delivery address. Incomplete or inaccurate information may result in revised pricing or delays in confirmation.

The client remains responsible for ensuring that the goods are legally eligible for import into the United Kingdom and fully compliant with applicable regulations, standards, and certifications.
